

O1 Purpose of the Supplier Code of Conduct

Basic understanding The E-T-A Group supports the United Nations Sustainable Development Goals (SDGs), and helps to ensure a sustainable future through its activities. When further expanding, implementing, and achieving sustainable purchasing procedures, we also align our work to the content and goals of sustainable development. As part of the supply chain, we integrate our suppliers and business partners by applying and requiring the following basic expectations and objectives from our suppliers and business partners as well. The Code of Conduct is based on the United Nations Global Compact, as well as national and international laws and regulations. These include, for instance, the Supply Chain Due Diligence Act (LkSG), the United Nations Universal Declaration on Human Rights, the Guidelines on Children's Rights and Business Principles, the UN Principles on Business and Human Rights, and the ILO International Labour Standards. In the course of their collaboration with us, we expect that our suppli-Compliance with the law ers and business partners comply with the above laws and regulations. If the legal regulations in the countries where they are active deviate from this, the stricter regulations/requirements must be complied with.

02 Human rights and working conditions

Humane treatmentE-T-A does not tolerate any human rights violations, including discrimination, and works to ensure proper and fair working conditions.
Although we do not currently fall under the regulations of the Supply
Chain Due Diligence Act, we adhere to its principles. We also require
this of our suppliers and business partners.**Our suppliers and business partners undertake:**Respecting human rights- to respect human rights and ensure humane treatment.
- to prevent all kinds of discrimination and unequal treatment of employees and comply with international laws in this respect.
- to make a positive contribution to protecting and promoting human
rights and proper working conditions through their own activities.

In cases where freedom of association and the right to collec- tive negotiations are restricted by law, alternative opportunities for free and independent association among employees must be granted for the purpose of collective negotiations.	

03 Health protection, workplace safety

Workplace safety	We require our suppliers and business partners to fully accept corpo- rate management obligations for occupational safety and health pro- tection, in order to ensure and continuously promote the safety and health of employees in the workplace.

Occupational protection, work- related accidents & illnesses Drinking water, sanitary facilities	 to implement and ensure occupational and health protection in accordance with internationally recognised standards, such as ISO 45001 or the ILO conventions. to ensure access to sufficient quantities of drinking water and clean and sanitary facilities. 	
Health & safety communication, training	 n, - to inform employees of applicable health and safety regulations and regularly train them on these. 	
Physically & mentally taxing work	to prevent excess physical or mental fatigue among workers through suitable measures.	



Safety on machines / in production

- to ensure safe operation/work on machines and in production through providing suitable training to affected employees on work instructions for machinery and systems, in order to prevent work-related accidents.

04 Environmental protection, ecological responsibility

Environmental protection & responsibility	E-T-A is committed to protect and maintain a liveable environment. We take protecting the climate very seriously as a multi-generational project, and do our part as a company and as a community. We ex- pect the same of our suppliers and business partners.	
Environmental & energy man- agement	We know that many of our suppliers and business partners have al- ready introduced a certified environmental management system, and that they may also have a certified energy management system. We request that they maintain these and actively engage in environmen- tal protection. For suppliers who do not yet have a certified environ- mental and energy management system, we require that they intro- duce an adequate environmental and energy management system that takes all environmental and energy aspects into account when- ever possible.	
Human and nature	In general, we require that our suppliers and business partners halt any harmful soil changes, water or air pollution, noise emissions and excessive water usage, in particular if this harms human health and/or significantly impacts natural systems for food production.	
	Our suppliers and business partners undertake:	
Consumption of raw materials	- to reduce the use and consumption of resources during production and the generation of waste of all kinds, including water and energy, to a minimum.	
Energy consumption/efficiency	 to monitor and document energy consumption and to find economi- cal solutions to continuously improve energy efficiency and minimize energy consumption. 	



Responsible purchasing of materials	- to design their supply chains in a responsible manner when select- ing preliminary materials and suppliers. In particular, to avoid human rights violations and environmental harm related to purchasing, and to fulfil relevant due diligence obligations.
Products, processes	 to optimise products and processes so as to reduce environmental pollution and impacts, and to avoid them if possible. to ensure resources are handled carefully and efficiently, thereby avoiding the waste of resources.
Wastewater and water consumption	- to standardize, monitor, check, and treat wastewater from operating procedures, production processes and sanitary facilities before it is discharged or disposed of and to treat it if necessary. Furthermore, measures should be introduced to reduce the production of wastewater.
Handling waste	- to establish a systematic approach for identifying, handling, and re- ducing waste as well as for disposing of or recycling it in a responsi- ble manner, while complying with relevant laws. In particular, chemi- cals and other materials that would be hazardous if released into the environment must be identified and handled so as to ensure safety when handling, transporting, storing, using, recycling or reusing and disposing of these substances.
Hazardous materials	- to reduce the use of hazardous materials in products (environmen- tally compatible products!) and production to a minimum or at least to use less hazardous materials and pollutants through substitution test- ing.
Prohibited materials/ material restrictions	- to comply with and fulfil material prohibitions and/or restrictions or any approval and reporting/registration obligations if these are di- rectly applicable to them by law. In addition, our suppliers declare their willingness to also support us and our customers in fulfilling our obligations with respect to material prohibitions and restrictions that do not directly affect them, such as the RoHS and REACH.
Air/noise emissions	 to standardize and routinely monitor, test, and treat their emissions from operating processes as needed (air and noise emissions) as well as greenhouse gas emissions before they are released.



05	Ethics	
Corporate integrity	We require that our suppliers and business partners, as well as their managers and employees engage in proper ethical conduct and ethi- cally appropriate business activities at all times. Ideally, a written Code of Conduct should be prepared and publicly disclosed for this purpose in order to advertise and define regulations and working methods and as a declaration of commitment.	
	Our suppliers and business partners undertake:	
Prohibition against fraud, corruption, extortion & money laundering	- to work to prevent and halt all kinds of fraud, corruption, extortion and money laundering, and to comply with associated laws.	
Fair business practices, competition & antitrust law	 to comply with standards for fair business practices, fair advertisement and fair competition. In addition, applicable antitrust laws must be applied which prohibit agreements with competitors as well as other activities that influence prices or conditions. Furthermore, these regulations prohibit agreements between customers and suppliers for the purpose of restricting the freedom of customers to autonomously determine their prices and other conditions for resale. to work to prevent any anti-trust law violations in their supply chains 	
Protection of intellectual property	 to work to prevent any anti-trust law violations in their supply chain to respect rights to intellectual property, and design technology an knowledge transfers so as to protect intellectual property rights and customer information. 	
Import & export controlling	 to comply with national and international regulations on import & export controlling and ensure through suitable processes that transactions and activities with third parties and with E-T-A do not violate export controlling and sanction laws, as well as to provide any necessary verifications and information promptly. 	
Avoiding conflicts of interest	- to ensure that employees on all levels do not make their business decisions dependent on private interests or personal considerations, and that decisions are made in a transparent manner, based on ob- jective considerations.	



Data protection/information	 to use special care and appropriate technical and organisational measures to safeguard protected information and data. Personal data is only collected, processed and used as permitted un- der relevant laws and as necessary for the collaboration.
Conflict materials	- when using, purchasing or delivering products/materials that contain the conflict materials tin, tungsten, tantalum and gold (3TG) as well as the raw material cobalt, to establish processes to ensure that due diligence obligations to promote responsible supply chains for miner- als from conflict and high-risk regions are fulfilled as far as possible, and to transfer this due diligence obligation to its suppliers as well and prepare relevant reports on this matter. Suppliers must prepare reports on their 3TG and cobalt supply chain upon request, while maintaining trade secrecy. The Conflict Minerals Reporting Template (CMRT) and/or Cobalt Reporting Template (CRT) from the Responsi- ble Minerals Initiative must be completed and submitted for this pur- pose.
	As a common goal, smelters and refineries without appropriate, au- dited due diligence processes should be avoided in the supply chain.
	(Based on and in accordance with the principles of the Organisation for Economic Cooperation and Development, OECD).
Whistle-blower portal and non-retaliation	E-T-A has introduced an anonymous whistle-blower portal to allow for reporting anonymous tips and violations of the law, the Code of Conduct, or other guidelines. Because tips are submitted anonymously, this ensures that they will not result in retaliation. This portal is also available to suppliers and business partners (https://eta.integrityline.com/).
	We expect that our suppliers and business partners take suitable measures to establish their own anonymous whistle-blower portals as well.
Supplier responsibility	We expect that suppliers promote and implement the objectives, re- quirements, and principles described in this Code of Conduct in their supply chains as well and as far as possible through suitable measures.

06 Management system

If such a management system is not already in place, we expect that our suppliers and business partners introduce an appropriate management system for the purpose of supporting and promoting compliance with this Code and relevant laws and regulations, among other objectives.

We consider risk assessments, implemented guidelines, processes and pictograms, clearly communicated roles and obligations, training measures and specific instructions, the definition and evaluation of measurable objectives, as well as functional controlling systems as further important content and functions of a comprehensive management system, and as foundational for successfully implementing the Supplier Code of Conduct.
